#### COMMITTEE OF THE WHOLE SESSION

On the final day, the Chair discussed some business items related to future SWGDAM Regular Meetings, and highlighted the efforts and achievements of specific SWGDAM members who have gone ‘above and beyond’ in these past 6 months.

#### LEGISLATIVE UPDATE

Jake Moldowsky, the SWGDAM Executive Secretary, then gave his regular presentation on relevant legislative and caselaw activity developing since the July SWGDAM meeting. Mr. Moldowsky covered a range of legislative topics such as federal prerogatives for forensic science in 2026, state laws passed around rapid DNA, IGG, genetic privacy, and court opinions discussing the constitutionality of surreptitious collections, the bounds of the Fourth Amendment Search and Seizure in sample collection, and the evidentiary weight and boundaries of probabilistic genotyping technology, such as STRMix. The Legislative Update presentation will be made available to SWGDAM members for reference in discussions with their legal counsel and laboratory leadership.
